The Volunteer understands that the activities may include but are not limited to, work in a food preparation and kitchen environment near heavy equipment, kitchen utensils, pallets of bulk food product and cases of boxed goods.

The Volunteer hereby freely, voluntarily, without duress, and in consideration of being allowed to volunteer executes this Release under the following terms:

1. Release and Waiver. Volunteer does hereby release and forever discharge and hold harmless THE SANDWICH FOUNDATION, its successors and assigns from any and all liability, claims and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with THE SANDWICH FOUNDATION.

Volunteer understands that this Release discharges THE SANDWICH FOUNDATION from any liability or claim that the Volunteer may have against THE SANDWICH FOUNDATION with respect to any bodily injury, illness, death, or property damage that may result from Volunteer's Activities with THE SANDWICH FOUNDATION, whether caused by the negligence of THE SANDWICH FOUNDATION or its officers, directors, employees or agents or otherwise. Volunteer also understands that THE SANDWICH FOUNDATION does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

It is the policy of THE SANDWICH FOUNDATION that, while minors may participate with supervision in such Activities as are appropriate for their age, ultra hazardous Activities are not permitted by anyone under the age of 18.

2. Medical Treatment: Volunteer does hereby release and forever discharge THE SANDWICH FOUNDATION from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteers activities with THE SANDWICH FOUNDATION.

3. Assumption of Risk. The Volunteer understands that the Activities include work that may be hazardous to the Volunteer.

Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases THE SANDWICH FOUNDATION from all liability for injury, illness, death or property damage resulting from the Activities.

Volunteer understand that I will not receive any compensation, neither now nor in the future for the above. 6. Other. Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the Province of Alberta, and that this Release shall be governed by and interpreted in accordance with the laws of the Province of Alberta. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
